- 1. Call to Order at 6:30pm by N. Bostrom.
- 2. Pledge of Allegiance led by Color Guard members of Boy Scout Troop 589.
- 3. Final Call for Registration of Attendance and Proxy Vote Forms by N. Bostrom.
- 4. Establish proof of Notice of Annual Meeting (Bylaws Article 3.3) by N. Teske and N. Kirk of Gassen Management Company.
- 5. Designate Quorum of the Members (Bylaws Article 3.4) by N. Bostrom.
- 6. Designate Quorum of the Board (Bylaws Article 7.3). Eight of nine Board members were present: N. Bostrom, D. Snodgrass, K. Alcindor, N. Dilks, L. Frey, M. Perry, M. Poppler, and K. Snapp. Absent: B. Maves.
- 7. Treasurer's Report (Bylaws Article 9.7d) by M. Perry, and M. Mullen (CPA Mullen & Associates). Report accepted as amended.
- 8. President's Report by N. Bostrom. Report accepted.
- 9. Credentials Committee Report by N. Teske, N. Kirk, M. Perry, and K. Alcindor.
- 10. Approve minutes from 2011 Annual Meeting. Minutes approved as presented.
- 11. Open Forum of the Members.
- 12. Nominating Committee Report (Bylaws Article 6.1) by D. Snodgrass. Candidates nominated prior to Annual Meeting: S. Wolff, M. Perry, and M. Lynner. Candidates nominated from the floor: J. Holt. Candidate nominations were approved.
- 13. Candidate Statements by S. Wolff, M. Perry, M. Lynner, and J. Holt. Attempt was made (motion by J. Holt and seconded by J. Pint) to remove all current Board members according to the process as outlined in Association Bylaws (Article 5.3). Discussion ensued.
- 14. After a period of time the meeting was adjourned by N. Bostrom (incorrectly) and room cleared.

- 15. Several individuals continued to meet outside of City Hall building (in parking lot) and correctly (according to Article 5.3 of Bylaws) removed N. Bostrom, D. Snodgrass, M. Perry, K. Alcindor, L. Frey, N. Dilks, M. Poppler, and K. Snapp from the Board. These same individuals incorrectly (according to Article 5.3 of Bylaws) attempted to place seven new members on the Board; overlooking the fact that B.
