## Open Forum: One homeowner addressed the Board.

# Management's Report:

- Golf Cart:
  - Has been purchased along with logos and has been productive/successful.
- Tot Lots
  - o Autumn Woods is done with the ADA approved mulch.
  - Tuscany Hills will also have ADA approved mulch.
  - All of equipment has arrived.
- Fall Newsletter:
  - Content list has been completed with a goal to get it to Clint by October 1<sup>st</sup> in order to get it in the mail by October 15<sup>th</sup>.
- ARC Applications:
  - Eight (8) were submitted with seven (7) approved and one (1) denied.
- Village Rd:
  - It was determined that the tunnel is the City's responsibility. A memo has been sent to the City addressing the concerns that Jonathan has regarding the tunnel.
- Neighborhood Assessments:
  - There has been some common themes, such as outside storage and upkeep of the home.
  - So far there has been a positive response to this new system.

# **Board Resolution(s):**

- ARC Guidelines:
  - The Board went over each page of the ARC Guidelines that the ARC Committee given to the Board to review. Adjustments were made while they went over the guidelines.

- Fence at Autumn Woods:
  - There was a discussion about the fence at Autumn Woods, specifically the chain link portion of the fence. Traci brought this to the Board for direction on whether to repair, replace, or remove the fence.

attend the next Board meeting to express their opinions. If they cannot make it Traci will ask for their input before the meeting.

#### **New Business:**

- Monument Updates:
  - Autumn Woods:
    - Both of the monuments that Jonathan was seeking City approval on were grandfathered in.
  - Tuscany Hills was not part of the initial scope but that will be looked into to make sure on if it can be included or not.
- Mailbox Committee:
  - The committee is still waiting on the approval from the post office for the marked sites before any concrete can be poured.
  - o Eitel is completed.
- Eitel Committee:
  - The committee is going to put forward a contract with a realtor for the Board to review and approve.
  - There is going to be a piece about the Eitel House and the decision to move forward with selling it in the Newsletter.
- Reserve at Autumn Woods:
  - Lenar continues to move forward with the Reserve at Autumn Woods.
  - o There is looking to be about 84 homes that will be in this association.
  - o It will have a connecting trial to the trails in Jonathan.
  - There will be a meeting this week between Emily, Matt with the City, and Lenar.
